## Observations & Findings:



During the inspection, team found space for infrastructural, instructional & other related facilities to grant extension for provisional affiliation of BBA (120 seats), BCA (120 seats) & BA (J&MC) (60 seats) courses.

## Suggestions:

1. The authority of Sityog Institute of Technology, Growth Centre, Jasoiya More, Aurangabad – 824102, is advised to appoint Faculty Members according to the cadre ratio specified in AICTE norms before the commencement of classes for the academic session 2024-25.
2. Additional relevant books and journals/e-journals need to be made available in the library. The institute should become a member of the National Digital Library.
3. Need to be upgrade of computer hardware and licensed software in labs & library.
4. Provisions should be made to watch MOOCs courses through SWAYAM at the college.
5. Additional smart classes with digital boards are required.
6. Wi-Fi facility is required to be more strengthened.
7. Classrooms should be well furnished.
8. The Institute campus should be clean, tidy and free of dust.

## Recommendations:

Based on observations and findings, provisional affiliation may be granted to Sityog Institute of Technology, Growth Centre, Jasoiya More, Aurangabad - 824102, for the academic session 2024-25, for the following courses with indicated seat capacities: BBA (120 seats), BCA (120 seats), and BA (Journalism & Mass Communication) (60 seats).
